

TENDER CALL NOTICE No.1(Pur)/2010-11 dt. 30.6.10

Sealed tenders for supply of medicines for the year 2010-11 are invited from registered dealers/ manufacturers / authorized distributors/ authorized agencies having up-to-date VAT & IT clearance certificate, up-to-date drug license in conformity with detailed tender documents. The Tender documents with required details can be obtained from the Office of the Director of Animal Husbandry & Veterinary Services, Orissa, Mangalabag, Cuttack-1 on payment of Rs. 10,000/- (Rupees Ten thousand) only + VAT 4% in shape of cash (Non refundable). The same can be obtained by post on payment of Rs.10,050/- (Rupees ten thousand and fifty) only + VAT 4% in shape of Bank Draft issued in favour of "Establishment Officer", Directorate of Animal Husbandry & Veterinary Services, Orissa, Cuttack payable at SBI Link Road Branch, Cuttack at least one week prior to last date, accompanied by the request in plain paper alongwith a self-addressed envelope of 9" x 12" size with postage stamp of Rs. 50/- affixed on it.

2. The cost of Tender Paper with documents is compulsory and non-refundable and the receipt so obtained against payment should be enclosed in original alongwith tender papers.

3. The expiry date of medicines to be supplied should not be less than 12 months from the date of delivery.


